As is often the case with funding opportunities, IDPH is moving swiftly to meet the deadline for a grant that recently became available through the Centers for Disease Control and Prevention. And, we need your help.

In our application for the Strengthening Public Health Infrastructure for Improved Health Outcomes grant, IDPH is proposing to provide money to local public health departments to build infrastructure. If you have any suggestions about what needs there are at the local level, please take a few minutes to tell us about them. I know this is short notice, but the survey is made up of only one question; spend as much or as little time as you like. *Note: please do not include your name or contact information in your suggestions.* This will ensure that you are able to apply for these funds should we receive funding.

State accreditation site visit goes well

This week, IDPH welcomed a team of three site visitors from the Public Health Accreditation Board (PHAB) to conduct a beta test of the national public health accreditation process. Similar to the recent site visits by IDPH staff to six counties across Iowa, these site reviewers conducted a "mock" accreditation review in order to evaluate their processes while assisting IDPH in preparing for a formal accreditation review at some point in the future. Iowa is one of only eight states selected to participate in the beta test, so this was quite an honor for the department.

I am very proud to report that the review was a great success. While there were certainly some things identified that the department needs to work on, the site reviewers were generally very complimentary. In particular, they were impressed by some of the innovative things that have been done around Iowa Public Health Modernization and the contracting process quality improvement project. They also commented on the strong relationships between state and local public health and the shared passion to do what is best for Iowans.

Although this review does not mean IDPH is officially accredited by PHAB, it does mean that we are well positioned once the final accreditation process is established. For now, let me just say that I could not be more proud of the IDPH team and public health in Iowa in general. Second Healthy Communities magazine now available

I am happy to tell you about a new publication available from IDPH. Told in rich language by more than a dozen authors, including nationally recognized walking enthusiast and health advocate Mark Fenton, the free Healthy Communities magazine is the collective story of more than 25 towns, cities, and neighborhoods across Iowa that have taken steps to make their communities healthy places to live, work, and play. With more than 50 photographs taken by the Iowa Department of Natural Resources and other contributors, the 68-page publication is the second such magazine produced by IDPH. The first appeared in 2007 and coincided with the "Barn Raising" Governor's Conference on Public Health.

By the end of this month, each local public health agency will have received a copy of Healthy Communities to place in their client waiting area, share with board of health members, or use in inspiring local coalitions to pursue projects that contribute to a healthy community.
