1. INTRODUCTION

Commercially available instruments for road-side data collection take highly limited measurements, require extensive manual input, or are too expensive for widespread use. However, inexpensive computer vision techniques for digital video analysis can be applied to automate the monitoring of driver, vehicle, and pedestrian behaviors. These techniques can measure safety-related variables that cannot be easily measured using existing sensors.

This project implemented and tested a digital video analysis system for use at intersections based on a single camera design. As part of the research effort, a prototype video recording system was developed for field deployment. It was designed around the objective of recording high-quality video at an intersection for up to one week without any intervention. The design of this system is described in Section 2. To simplify the analysis of the recorded video, a standard camera– intersection configuration was adopted. This configuration is described in Section 3. The algorithms used to track objects in the digital video and their implementation are described in detail in Section 4. Video was recorded at both urban and rural non-signalized intersections and was analyzed using the digital video analysis techniques developed in this project. These intersections and analysis results are described in Section 5. A graphical computer interface was implemented in order to simplify and automate the data analysis and the data review process. A step-by-step guide to the usage of this software is provided in Section 6.

2. DESIGN OF A VIDEO RECORDING STATION (VRS)

The primary advantage of digital video analysis is the ability to automatically track vehicles and quantify the frequency of events over a long period of time. In this research, a low-cost digital camcorder is used to collect video from non-signalized intersections. The recorded video is used to test the feasibility of using digital video analysis for traffic safety studies. The video taping sessions were limited to a maximum length of one hour due to the storage limits of current camcorder technology. Because the recording of video does not require any attention, it would be desirable to have the capability to record video for much longer periods of time.

2.1 Design Constraints

In order to develop this capability, a portable video recording station was designed around the objective of recording high-quality video for up to one week (168 hours) without any intervention. This design constraint was given the highest priority. The second most important design constraint was to find a low-cost solution through the use of consumer-grade off-the-shelf parts and open-source software. While satisfying these two objectives alone is not particularly challenging, the design problem became much more challenging when a third design constraint was enforced. Because power is not typically available along the road or at all intersections, we required that the station be completely self powered for the one-week recording period. Satisfaction of these three design constraints made the problem much more difficult, as it forced consideration of the tradeoffs between low-power and low-cost hardware as well as the tradeoff between battery and solar power. A number of additional design constraints were enforced.

Some of these constrains were that the stations should be capable of operating both during the day and the night, that the stations should be mobile, and that the station should be weather resistant and capable of running across a wide range of temperatures. Furthermore, we focused on making the production process scalable; thus, we used only commonly available parts that could be easily assembled with minimal work where possible. We also have focused on a modular approach that utilizes components that are easily swappable to allow for easy repair or replacement.

2.2 Prototype Design

Given that no known consumer–grade solution is available for recording one week of video, we relied upon the use of a general purpose computer. To minimize power constraints, we needed a computer that was designed for minimal power consumption. While using a laptop was a possibility, laptops are relatively expensive, not sufficiently customizable, and include features not necessarily relevant to the current application. Therefore we went with a specialized motherboard and central processing unit (CPU) designed for low-power embedded applications. The motherboard comes with a high-efficiency DC to DC converter designed to regulate voltage and current supplied to the motherboard when powered by a 12-volt battery, as is typical in automotive applications. The CPU and power supply are both fanless and do not require active venting.

While the majority of embedded systems available today utilize specialized architectures, this motherboard and CPU are compatible with the x86 architecture. This minimizes the amount of specialized software required for development of applications using this hardware and enables the use of the open-source operating system Linux. Linux is highly customizable and can be configured to run in a low power consumption mode. While some specialized software was written in C to manage the video capture, memory buffering, and file writing operations, the video capture card drivers were open source.

In order to record one week of video with a reasonable video compression rate, a 250 gigabyte hard drive is required. A standard desktop computer hard drive was selected in combination with a swappable hard drive system such that the digital video could easily be removed from the recording station and inserted into another computer for data analysis. Although a laptop hard drive is designed to consume less power than a desktop hard drive, the cost is significantly greater. The operating system software can be customized to minimize the power consumption of the hard drive by caching video in memory and spinning down the hard drive in between writes from memory. The hard drive has all software preloaded such that the computer boots from the hard drive and immediately begins recording video.

Analog, rather than digital, cameras were chosen as the most appropriate solution to capture video. They are low power, low cost, ruggedized, and the camera that we selected is pre-equipped with infrared light-emitting diodes for active illumination of the scene at night. An analog to digital video capture card is required for use of this camera. The capture card converts the video into a MPEG compressed format using a specialized digital signal processor, thus minimizing the processing load and power consumption of the CPU.

The most constraining aspect of the design was finding a power source capable of supporting a running time of one week that was both low cost and mobile. While a solar power solution was considered feasible and could allow the system to run more than one week, that approach suffers a number of limitations. First, the complexity and price of the system would be unacceptably increased. The lack of light at night and during certain weather conditions would necessitate both an onboard battery and charging system. Continuous video recording could not be guaranteed. Furthermore, interaction with the system will already be periodically required in order to collect the digital video for analysis. Therefore, the system was designed to run completely on batteries. Given the power consumption ratings of the processing hardware and the one-week desired running time, four high-capacity deep-cycle marine batteries are necessary.

A weatherproof case was selected to house the motherboard, hard drive, and power converter. This case allows for mounting of the swappable drive bay to support easy removal and insertion of hard drives. The batteries are housed in individual weather-proof polypropylene cases. The camera is already ruggidized and is affixed atop a four-foot pole extending out from the base. Figure 2.1 shows a photograph of the computer components and camera and two cut-away computer-aided design (CAD) diagrams of the complete system.

2.3 Prototype Components and Cost

The prototype design presented in the previous section is the lowest cost solution that meets all of the other design constraints. The overall cost was minimized by using consumer-grade off-the-shelf parts repurposed for the task of video recording. The parts for this system can be acquired for an approximate total of \$1,100 when purchasing the components individually. However, it is expected that the cost could be reduced if bulk purchases were made. The construction time is on the order of 10–15 hours, but because the design is simple and assembly is straightforward, the associated labor costs are expected to be minimal. The remainder of this section provides a list of the necessary components and their prices.

Motherboard—VIA EPIA CN10000EG Fanless Mini-ITX Mainboard, \$185.00 This motherboard is well suited to this application because it does not consume much power or produce much heat. Any heat generated by the system is dissipated through a heat sink in the center of the board. It has a PCI slot for the capture card and is one of the smallest form factors available.

- Memory—AMPO 512MB 240-Pin DDR2 SDRAM 533 (PC2 4200), \$40.00 This is the amount and type of random access memory (RAM) necessary for this motherboard and application. Although less RAM would minimize cost, this amount will allow for buffering of video in memory. Buffering of video will minimize the amount of time that the hard drive will need to spin and reduce power consumption.
- Video Capture Card—Hauppauge 980 Personal Video Recorder, \$130.00 This video card has onboard compression and is well supported under the open-source operating system Linux. This solution for video capture removes the burden of image capture and conversion to the MPEG video format from the CPU and thus helps to minimize power consumption. However, the fact that the card requires a PCI card limits the range of motherboards that are compatible and is slightly more expensive than other video capture solutions.
- Case—12 VDC Weatherproof Enclosure with Mounting Plate, \$150.00 This enclosure is weather rated and was intended for use with outdoor electronic devices. It is large enough to fit all of the computer components. An internal mounting board can be configured to support a mini-itx motherboard, power supply, and hard drive.
- Hard Drive—Western Digital Caviar SE WD2500JS 250GB SATA, \$80.00 Given a reasonable MPEG compression, this size hard drive will be sufficient to hold seven days worth of digital video. A desktop hard drive rather than a low-power laptop hard drive is used in order to minimize the cost.
- Hard Drive Swap Kit—SanMax PMD-96I Black Mobile Hard Drive Rack, \$20.00 The hard drive will be mounted using this rapid swap kit to support easy removal.
- Camera—Color Infrared Day/Night Sony Super HAD CCD Camera \$120.00 This camera provides an excellent picture during the day while using almost no power. At night, a high-efficiency infrared LED array activates automatically, which allows video to be recorded while still consuming very little power. It has a rated night-time seeing distance of 50 feet.
- Power Converter—Automotive 90W DC-DC Power Supply, \$80.00 This power converter takes a 12 VDC input and produces a regulated 12 and 5 volt output necessary to power the motherboard, hard drive, and camera. The converter has an 80 to 90 percent efficiency rating.

Batteries—4 Interstate SRM-27B 12 VDC batteries, \$350.00

These are deep-cycle marine batteries designed to sustain cycles of full charge to complete discharge. It is estimated that four batteries will power the system for seven days under nominal conditions. Temperature, battery usage and discharge, and charging rate will affect the total running time.

Battery Charger—BatteryMinder 12117, \$50.00

This charger has a large enough capacity while also providing functions that can enhance battery life, such as desulfation and over/under charging protection. It has a visual monitor that tells charge state and quick-connect cords.

Battery Cases—4 Group 27 Battery Boxes, \$45.00

These vented boxes are designed to provide good protection from the elements and also provide mounting straps.

3. DIGITAL VIDEO RECORDING PROCEDURE

In order to simplify the digital video analysis procedures, a standard camera–intersection configuration was adopted. The standard configuration requires that a single digital video camera is placed 50 feet from the lane of interest. The camera should be mounted on a secure tripod in order that the system stays fixed and is not perturbed by small gusts of wind. The camera height should be set to 4 feet. The rotation of the camera must be set such that the view direction of the camera is perpendicular to the lane of interest. The camera position parallel to the lane of interest is unconstrained. For the study of intersections, it was found ideal to position the control device (e.g., stop sign) approximately in the center of the camera's field of view. An image taken from the camera's point of view in the standard configuration is shown in Figure 3.1 for a non-signalized four-way stop.

Once a camera is set up in the standard configuration at an intersection, a calibration procedure must be followed. This procedure allows the digital video analysis to estimate distances in the scene (in feet) using distances in the images (in pixels). The procedure requires that two planer markers are placed within the camera's field of view along the intersection of interest. Each marker is an 8.5 inch by 11 inch checkerboard pattern printed onto a rigid material and mounted to a tripod. A checkerboard pattern is used so that the digital video analysis can precisely locate the marker at the sub-pixel level. The markers must be set up parallel to the lane of interest and as close as possible to the lane of interest. Although the optimal calibration process would place the calibration markers in the center of the lane of interest, practically, this can be difficult. It was found that placing the markers just outside of the lane of interest was sufficient for vehicle tracking purposes. The distance between the checkerboard centers must be set as close as

possible to 10 feet. Only a single video frame is needed with the un-occluded markers for the calibration. The markers need not stay in place for the entire duration of the video. The calibration process can be completed at any time during the video recording as long as the camera remains fixed throughout.

Once the calibration process is completed, a conversion factor between distance in pixels in the camera image and distance along the calibration plane in the scene can be determined. However, the factor resulting from this calibration is only an approximation. Deviations from this conversion factor are expected when the tracked objects do not lie on the calibration plane (i.e., the objects are closer or farther), or when the tracked objects are on the calibration plane, but distant from the location of the markers (i.e., just entering or leaving the image frame). For the purposes of vehicle tracking in the lane of interest, these deviations are minimal. A calibration process involving more markers placed at a range of known camera depths could be used to minimize this error if needed for a particular application. This approach was avoided in order to make usage of this tool as simple as possible without introducing an unreasonable amount of error.

4. DIGITAL VIDEO ANALYSIS

The digital video analysis begins with a frame by frame extraction of objects in the scene. These objects are extracted by comparison of each frame with an image of the scene that does not contain any objects of interest (i.e., vehicles). Then, a position-based criterion is used to link objects across frames in order to create object tracks. The object tracks are analyzed to determine object identity (i.e., vehicle, pedestrian). A dynamic occlusion detection and correction analysis is conducted in order to uniquely identify each object in the scene and correct the estimated object center of mass. The output of the analysis is a dataset containing the position, velocity, size, and identity of each detected object in the scene. The following sections describe the steps of this process in more detail.

4.1 Object Detection

The output of the object detection stage is an object detection list. This is a list of all detected objects in each video frame that specifies the position and size of each object. Because a singlecamera approach is taken in this research, it must be assumed that the detected objects are on or near the calibration plane. Thus, the positional information is limited to horizontal and vertical position estimates, and the size estimates of the vehicle refer only to the side profile of the object.

Each frame of the recorded digital video is extracted to a separate image. Each image is then point-wise compared to an image of the scene that does not contain any objects of interest. This image is referred to as the background image. Prior to proceeding with object detection, the user should select a single frame from the video that does not contain any objects of interest or any other moving objects. While an automatic background selection algorithm is available to the user, the algorithm is relatively slow and will not guarantee that the image does not contain any

objects of interest. It will only guarantee to find images without moving objects. The automatic algorithm will select scenes where vehicles are temporarily stopped. However, the user can use the automatic algorithm and then proceed by manually selecting a different background image if the automatic selection is inappropriate.

Each image is converted to gray scale prior to point-wise comparison between the background image (B) and the scene image (I). The result is an intensity difference image (D). Pixels with intensity greater than the object detection threshold θ are set to a value of 1. The rest of the pixels are set to a value of 0. The result of this operation is an object mask image (M) that specifies the candidate locations of objects. The threshold θ can be adjusted according to the image noise levels of the camera in order to minimize the number of false alarms. A high θ can also be utilized to combat false alarms due to slight movement of objects in the background. For example, wind can cause trees or signs to move slightly.

To further reduce the sensitivity of object detection process to false alarms, a series of morphological operations are performed on the object mask. These operations include eroding the mask through a majority operation in order to eliminate regions that are above threshold but too small to be an object of interest, dilating to assure that the entire object is captured within the extent of the mask, and finally closing to create convex regions that have no holes. Given the complexity of the point-wise comparisons and morphological operations, intensity images are down sampled by a factor of Δ prior to processing.

Once the object mask has been computed, separate regions are identified and labeled. A bounding box, center of mass, and area is then computed for each. Objects with an area less than a minimum area threshold ϕ are discarded. Objects with an area between ϕ and the minimum vehicle area threshold ν are labeled pedestrians. Objects with an area greater than or equal to ν are labeled vehicles.

Because the light levels in the scene change with time and the object detection algorithm depends on image intensity, any given background image will only be appropriate for use with images that were taken at a point nearby in time. To address this problem, the background is adapted slowly over time. For each frame f, a background image for the next frame B(f+1) is created based on the current background image B(f), the object mask M(f), and regions of the current image I(f) that contain no objects $M_i(f)$, such that

 $B(f+1) = B(f) * \beta + [B(f) \bullet M(f) + I(f) \bullet M_{i}(f)] * (1-\beta),$

where β is a parameter that controls the time constant of adaptation to changes in the scene, * denotes scalar image multiplication, and • denotes point-wise image multiplication. Using this approach, the background image is updated using the current image locations that do not contain objects.

4.2 Object Identification and Tracking

The output of the object identification stage is an object track list. Each object that has been identified across multiple frames is assigned a unique object track. Each object track is thus a list of references to the relevant object entries in the object detection list.

In order to link together objects across frames, each object in each frame of the recorded digital video is compared to each object in the previous frame. Those objects that are less than the threshold horizontal distance δ apart in space and have a difference in their area less than the threshold area difference α are considered candidate matches. For each object in the current frame, the single best match is determined by taking the closest candidate object from the previous frame. A reference to the object in the current frame is then added to the object track that refers to the matched object in the previous frame.

In the case that no candidate matches are found, a new object track is added to the object track list. All objects in the first frame of the video generate new object tracks. Objects entering the video frame also generate new object tracks. Objects that are temporarily occluded can also generate new object tracks upon re-appearance in the frame. Thus, the final object tracking list may contain multiple object tracks for a single object that moves through the scene, depending on the frequency with which the object was occluded by other objects or scene elements. Multiple object tracks may refer to some of the same object.

4.3 Object Track Filtering

The goal of object track filtering stage is to use the object tracks to improve the estimate of the object position, shape, and size. In the cases where an object is occluded at the edge of the scene or by another vehicle, the estimates of the object properties are poor. These estimates can be improved by making the assumption that the size of the object being tracked does not change during tracking. The object size (i.e., width and height in the image) for each frame that the object is detected can be treated as a sample. The best guess at the true object size is taken as the mode of all of the samples. If the observed size of the object in any individual frame is greater than σ standard deviations from the modal size, the size in that frame is reset to the modal size.

The object bounding box is then adjusted around the observed center of the object. If, however, one edge of the object is near the edge of the image, it is assumed that the object is partially occluded. In this case, the observed object center is a poor estimate of the true object center. Therefore, the new bounding box is set based on the visible object boundary instead of the object center. The object center is then adjusted according to the object boundary. This correction allows the vehicle to be correctly tracked even when it is only partially in the frame.

4.4 Object Occlusion Detection and Correction

The goal of the object identification stage is to create an object track list where each track uniquely corresponds to a single object in the scene, for every detected instance of the object in the video. This requires the correct identification of the object across occlusions. The first step is to detect occlusions. It is assumed that each object that enters the scene also exits the scene. If this assumption holds, any object track that either ends or begins within the object frame rather than at the edges of the frame can be assumed to have been occluded. Thus, the position of the first and last object of each object track is examined. If the first object of the track is near the image edge, the track is classified as having entered the scene. Otherwise, the track is classified as having been occluded. If the last object of the track is near the image edge, the track been occluded. If the last object of the track is classified as having been occluded before leaving the scene.

Once the occluded object tracks have been identified, the ends of the object tracks are examined for potential matches across occlusions. Due to the occlusion, spatial position is not a reliable indicator of object identity. Therefore, the visual features of the object are used as a matching measure. For each end of the object track that is occluded, a comparison is made between the visual features of the object and the visual features of objects within λ frames.

The SIFT algorithm (Lowe 1999) is employed to match visual features from object to object. This matching algorithm provides robust matching performance when the compared objects differ in position, rotation, scaling, and global changes in color and intensity. Although matching the visual features of objects is quite slow, it is more reliable than using position alone. Once links between object tracks have been established, the object tracks are reorganized to create a master object track list where each track uniquely describes a single scene object.

4.5 Noise Filtering

In order to minimize the effects of noise, temporal averaging is applied to the object tracks. A noncausal boxcar filter of size τ is run across the object center and bounding box coordinates separately. The filter size τ should be chosen based on the properties of the camera. It should be noted that a large filter can result in an underestimation of minimum and maximum velocities.

5. DEPLOYMENT OF DIGITAL VIDEO ANALYSIS SYSTEM AT NON-SIGNALIZED INTERSECTIONS

To obtain video that could be used to test the video analysis algorithms, the system was deployed to a total of five intersections in Ames, Iowa. Four non-signalized intersections on Bissell Road were chosen. The location of these intersections is shown on the map in Figure 5.1. The position and direction of the camera in the standard camera–intersection configuration is shown with a blue box and arrow. A video frame taken from each intersection is also shown.

A single, high-speed rural intersection at U.S. 69 and 190th was also chosen. A collision diagram and video frame from the recording are shown in Figure 5.2.



Figure 5.1. A map showing four intersections chosen for study on Bissell Road

These intersections and camera positions were chosen in order to test the system on a variety of backgrounds. Each background represents a different type of potential source of false alarms in the object detection process. The first urban intersection has a large tree in the background. The second and third urban intersections contain a view of the road crossing the lane of interest. The last urban intersection contains a large window that reflects light from passing vehicles. Three of the urban intersections are three-way stops, while one intersection is a four-way stop. The urban intersections are on the Iowa State University campus and experience heavy vehicle and pedestrian traffic during the day. Video was recorded from each intersection during the hour of 4:00 p.m., one intersection per day. Video was also recorded from a single intersection at 4:00 p.m. on four different days in the case that traffic varied as a function of day of the week. The rural intersection is a one-way stop where a low-volume road meets a high-volume, high-speed road. As can be seen in Figure 5.2, the stop sign on 190th is set well back from U.S. 69. Also, note that the traffic on U.S. 69 is visible. The collision diagram was provided by the Iowa DOT and shows the collisions within 500 feet of the intersection (inside the circle) in red and the remainder of collisions in green.



Figure 5.2. A collision diagram (1995-2005) of U.S. 69 and 190th and a corresponding video frame

A typical velocity profile of a vehicle that comes to a complete stop at an intersection is shown in Figure 5.3. Given the standard camera–intersection configuration, most vehicles are already decelerating when entering the system's field of view. However, it is typical for vehicles that come to a complete stop to exhibit a second stage of much more rapid deceleration as they approach the stop sign. Coming to a complete stop at any of the studied intersections is a rare event. It is estimated based on the video analysis that less than 20% of the vehicles stop completely. However, the accuracy of this estimate is difficult to judge given that the video analysis is susceptible to some false alarms and missed or incomplete vehicle tracks.



Figure 5.3. Velocity profile of a vehicle coming to a complete stop

A typical velocity profile of a vehicle that fails to come to a complete stop at an intersection is shown in Figure 5.4. While the majority of vehicles decelerate as they approach the intersection, many vehicles do not engage in the second stage of rapid deceleration needed in order to come to a complete stop. Instead, the vehicle either holds a constant velocity through the intersection, or accelerates once the stop sign has been reached. The vehicle in Figure 5.4 appears to switch from braking to acceleration once at the stop sign.



Figure 5.4. Velocity profile of a vehicle failing to stop

As can be seen in Figure 5.5, vehicles in the far lane, traveling in the opposite direction (in the negative direction), can also be tracked. Because the camera view does not contain the stop sign on the right-hand side of the intersection, only acceleration away from the intersection is tracked.



Figure 5.5. Velocity profile of a vehicle in the far lane

Figure 5.6 shows a histogram of average velocities for all objects tracked across the entire frame in a single video segment. Positive velocities indicate travel from the left to the right side of the frame (i.e., in the direction of the lane of interest). Object tracks with average velocities between -5 and 5 miles per hour are likely to be pedestrians or cyclists. Object tracks with large negative average velocities are vehicles traveling in the far lane. Object tracks with large positive average velocities are vehicles traveling in the lane of interest. Note that vehicles in the lane of interest tend to be traveling slower than the vehicles in the far lane, indicating that the vehicles are, at a minimum, slowing as they approach the stop sign.



Figure 5.6. Average velocity histogram for all object tracks

The object tracts with an absolute average velocity of greater than 5 miles per hour are shown in Figure 5.7. It is clear that the vehicles with an average absolute velocity greater than 12 miles per hour are traveling in the far lane given the shape of the velocity profiles. Note that the speed limit on this road is 15 miles per hour. The rest of the vehicles are traveling in the lane of interest, each showing a dip in velocity as they approach the stop sign. The stop sign is located at the 20 ft marker, and the majority of the dips occur in the 10–20 ft range. Note that the horizontal position plotted is for the center of the vehicle, not the leading edge. Therefore, it is the case that the minimum velocity for vehicles that fail to come to a complete stop at the stop sign occurs just before or at the location of the stop sign.

The results of the video analysis demonstrate the ability of the system to provide data that can potentially be useful for the understanding of driver behavior. The primary advantage of this approach is the ease with which measurements can be made. The system requires only a single video camera and a simple calibration procedure. Another advantage of the system is that a large amount of data can be collected relative to the effort and expense involved.

There are a number of disadvantages of the video analysis approach developed in this research. First, the analysis cannot guarantee that all vehicles passing through the intersection will be tracked or that classification of all objects as a vehicle or pedestrian is perfect. The analysis is also limited to the tracking of vehicles along a single lane. Many vehicles are not successfully tracked across the entire frame due to the inability to match vehicles across occlusions. It is likely that a multiple camera system would need to be utilized in order to reliably track all vehicles passing through an intersection. A multiple camera approach would require additional calibration procedures and increase the effort involved to configure the system. A final drawback of digital video analysis is that the analysis itself can be very time consuming. It cannot be conducted in real time. However, with additional development effort, the analyses could be made more efficient.

6. TRAFFIC DATA ANALYSIS APPLICATION (TDAA) USAGE GUIDE

The TDAA software is built as a graphical user interface within the data analysis tool MatLab. MatLab provides a rapid prototyping environment where development efforts can be focused on the overall approach used to solve a problem rather than the details. MatLab provides simple, straightforward functions for performing a range of image processing tasks. While the list of available tools in MatLab is large, for this application it was at times necessary to call upon other software to perform some tasks. TDAA is under continued development aimed at increasing the number of features and capabilities. Described in this document are the features associated with the first release of this software. The software is limited to processing video from the standard camera–intersection configuration described in Section 3. The next release of the software will be targeted at processing video from multiple cameras located at a single intersection. The analysis of video from multiple cameras will enable the precise localization of the 3D position of a vehicle in an

intersection. Work is also progressing on 3D visualization of the intersection. The latest development version of TDAA can be obtained using Subversion software (http://www.sourceforge.net/subversion) from our Subversion server (svn://hcvl.hci.iastate.edu/DOT/TDAA).

The remainder of this section walks through the graphical dialog boxes associated with the video capture and image extraction process, the image processing process, and data visualization process. Upon startup of TDAA, a master dialog box appears allowing the user to select which of these three activities the user would like to begin (See Figure 6.1).

6.1 Video Capture and Image Extraction

The primary dialog box for the video capture and image extraction process is shown in Figure 6.2. In TDAA, all data relevant to a given analysis are stored within a Project file. The default Project file is called 'default.tdaa.' All Project files are required to have the '.tdaa'file extension. The first step in the video capture process is to choose an existing project file or to create a new project file by clicking the **Choose** or **New** buttons in the **Capture Options** Panel.

A Project file selection dialog (see Figure 6.3) will allow the selection of an existing Project file or the specification of a new Project file. All Project files must be stored within the 'TDAA/FILES/PROJECT' directory for correct operation of the software.

Once at least one video has been added to the project, the video(s) in a project can be played by clicking the **Play Video** button shown in Figure 6.22. Note that video acquired using the **From Images** methods described above cannot be played currently.

6.2 Image Processing

The primary dialog box for the image processing process is shown in Figure 6.24. In TDAA, all data relevant to a given analysis are stored within a Project file. The first step in the image processing process is to choose an existing project file by clicking the **Choose** button in the **Active Project** panel.

The first processing step is object detection. In the **Object Detection** panel, the detection parameters can be set by clicking the **Set Options** button. The **Detection Options** dialog box will appear and parameters can be set by entering new numbers into the textbox (Figure 6.25). By default, the minimum vehicle area and minimum object area are set to ignore pedestrians. Lower the minimum object area to detect pedestrians as well as vehicles. A step size greater than one will cause the analysis to skip frames, resulting in less accurate, but faster object detection.

Before proceeding, the background must be setup by clicking the **Set Background** button in the **Object Detection** panel. As can bee seen in Figure 6.26, the **Background Selection** dialog shows one frame of one video. The frame and video can be selected using the textboxes at the bottom center of the dialog box or the next/previous buttons adjacent to the textboxes. For each video, a background image, starting image, ending image, and image processing boundaries must

be selected. Clicking the **Auto-Detect Background** button will automatically select a background. Some manual adjustment may be necessary.

Objects will not be detected beyond the boundaries. The boundaries help eliminate false alarms and speed up the image processing. As can be seen in Figure 6.27, clicking the **Upper Boundary** button will bring up a crosshair. A click on the image itself will set the upper image boundary.

As shown in Figure 6.28, once the upper boundary is set, the region above the upper boundary will be grayed out.

A similar process is followed for the lower boundary. The final result is shown in Figure 6.29. Only a small strip of the original image is likely to contain vehicles and the analysis is limited to that region.

Once an image that contains no objects of interest is found, the background can be set using the **Set Background** button. The text "Current Background Image" will be displayed on the image that is selected as the background image as confirmation of the selection (see Figure 6.30).

Once a background image is set, the starting image must be set using the **Set Start Frame** button. The text "Starting Image" will be displayed on the image that is selected as the starting image as confirmation of the selection (see Figure 6.31). The starting image can be the same as the background image or the starting image can be before the background image. However, the starting frame cannot be after the background image.

Once a starting image is set, the ending image must be set using the **Set End Frame** button. The text "Ending Image" will be displayed on the image that is selected as the ending image as confirmation of the selection (see Figure 6.32). The ending image can be the same as the background image or the ending image can be after the background image. However, the ending frame cannot be before the background image. Clicking the **Done** button will close the dialog.

The object detection process is started by clicking the **Detect Objects** button. During object detection, progress will be shown in the dialog box. The total number of processed frames, the number of detected objects, and the estimated time to completion (ETA) is shown (see Figure 6.33).

Object detection is a very time consuming process and can take many hours depending on the length and number of videos to be processed. Once completed, the textbox will provide a summary of the results (see Figure 6.34). The results can be reviewed by pressing the **Review Results** button.

The **Review Results** dialog allows inspection of each frame (see Figure 6.35). Detected objects are enclosed by a red box. A green number indicating the object number is printed at the center of the box. When finished reviewing the results, click the **Done** button to close the dialog box.

The second processing step is object track identification. In the **Object Identification** panel, the identification parameters can be set by clicking the **Set Options** button. The object track identification process is started by clicking the **Identify** button. During object track identification, progress will be shown in the dialog box. The total number of processed frames, the number of detected objects, and the estimated time to completion (ETA) is shown.

Object track identification is rapid. Once completed, the textbox will provide a summary of the results (see Figure 6.37). The results can be reviewed by pressing the **Review Results** button.

The **Review Results** dialog allows inspection of each frame (see Figure 6.38). Detected objects are enclosed by a red box. A green number indicating the object track is printed at the center of the box. The object track number should remain the same across multiple frames for the same object. When finished reviewing the results, click the **Done** button to close the dialog box.

The results can be reviewed by pressing the **Review Results** button in the **Shape Correction** panel. As can be seen in the left panel of Figure 6.40, the object box has been corrected for occlusion by the edge of the frame. In the right panel of Figure 6.40, the uncorrected center is biased to the right of the true center.

6.3 Data Visualization

The primary dialog box for data visualization is shown in Figure 6.42. The first step is to choose an existing project file by clicking the **Choose** button in the **Current Project** Panel. Once loaded, the first video frame and the velocity profile of the first object will appear in the **Object Display** panel and the **Graph Display** panel, respectively (see Figure 6.43).

The tracked object can be inspected one frame at a time by sliding the **Frame** toolbar (see Figure 6.44). The **Object Display** panel and **Graph Display** panel will automatically update. The **Object Display** panel shows the position of the tracked object using a red box. The **Graph Display** panel plots all of the object data as a blue curve. A red dot is also plotted corresponding to the observed value for the particular frame visualized in the **Object Display** panel. The visualized object is set using either the **Object Number** toolbar or textbox (see Figure 6.45).

When multiple objects are visible in the **Object Display** panel, any of the objects can be selected by clicking the **Select Object** button. A particular object can then be selected by positioning the crosshairs on the object within the **Object Display** panel and clicking on the object (see Figure 6.46).

A variety of plot types can be displayed on the **Graph Display** panel. The particular variables to be plotted on the mantissa and the abscissa are set in the **Single Variable Plot Options** panel (see Figure 6.47). The plot will be updated once the **Plot** button is clicked.

The plots in the **Graph Display** panel can show either filtered and corrected or unfiltered and uncorrected data depending on the **Use Equalized Length Data** button state (see Figure 6.48).

Histograms of data can be plotted in the **Graph Display** panel using the options available in the **Histogram Options** panel (see Figure 6.49). The Area, Time, and Range slider bars set minimum values that filter out data from the histogram. A histogram is plotted by selecting a variable in the selection box and clicking the **Create Histogram** button.

Multiple object tracks can be visualized simultaneously by clicking the **Select Histogram Range** button. Crosshairs will appear and two clicks in the **Graph Display** panel will set the lower and upper limits of the tracks to be displayed. The **Single Variable Plot** panel options will be applied to plot each of the tracks resulting in a joint visualization of vehicle tracks (see Figure 6.50).

A **Selected Object** toolbar will appear. It determines which of the object tracks are highlighted in blue and which object is visualized in the **Object Display** panel (see Figure 6.51).

Global Positioning System (GPS) coordinates can be entered to automatically obtain aerial images from TerraServer-USA or Google Maps. If the GPS coordinates and orientation of the camera are known, the vehicle positions can be plotted on the aerial images as they pass through the intersection (see Figure 6.52).

7. CONCLUSIONS AND RECOMMENDATIONS

Commercially available instruments for road-side data collection are significantly limited. Recent advances in computer vision techniques for digital video analysis promise to overcome many of these limitations. As demonstrated in this research, relatively inexpensive equipment can be used to record and analyze digital video to measure safety-related variables that cannot be easily measured using existing sensors.

This project implemented and tested a digital video analysis system for use at intersections based on a single camera design. Video was recorded at both urban and rural non-signalized intersections and was analyzed using the digital video analysis techniques developed in this project. The results of the video analysis demonstrate the ability of the system to provide data that can potentially be useful for the understanding of driver behavior. A significant advantage of the system is that a large amount of data can be collected relative to the effort and expense involved. Because this research is still in its early stages, there are a number of limitations to the developed video analysis approach.

Given the significant promise of this research, it is recommended that the technology developed in this project be deployed alongside an ongoing traffic safety study. With only minor increases to the cost of an existing study, the benefits of these techniques could be fully demonstrated. While there is significant risk in funding the development of technology through university collaborations, there is an enormous benefit. All software and hardware designs become available for the Department of Transportation to use without the additional costs levied when purchasing technology from commercial entities. Furthermore, the technology developed can be highly customized to the needs specified by Department of Transportation employees. It is recommended that the Department of Transportation further funds technology development projects to help solve transportation safety needs.
