Dear Senator Slater and Representative Swartz:

This report is submitted in compliance with Section 258A.4(2) of the Gode of Iowa.

A. The Board of Medical Examiners filed its rules relating to the duties of the Board on November 29, 1978, and these rules became effective on March 29, 1979.

Administrative rules adopted in 1982 relating to the duties of the Board of Medical Examiners are as follows:

- 1. Health 470-132.1 and 12(147A) "Advanced Emergency Medical Care". Extended the completion date of the EMT-D study program to December 31, 1982.
- 2. Health 470-136.5(148C) "Medical Examiners". Allows the Board to waive the three month period of direct supervision of a P.A. under certain circumstances when the P.A. is to be used in a remote clinic. Effective date was March 10, 1982.
- 3. Health 470-136.3, 4 and 11(148C) "Medical Examiners". Sets fees and provides for temporary and regular approval of physicians assistants and provides for biennial renewal of certification. Effective date was July 1, 1982.
- 4. Health 470-135.102(147) "Medical Examiners". Established dates for application to take FLEX examination and eliminated a free second examination if the first examination was failed. Effective date was July 2, 1982.
- 5. Health 470-135.102(147) "Medical Examiners". Established the requirements for taking the FLEX examination. Effective date was August 11, 1982.



- 6. Health 470-135.204(147) "Medical Examiners". Prohibits the use of pre-signed prescriptions and the use of rubber stamps on prescriptions. Effective date was August 11, 1982.
- 7. Health 470-135.102(1) (147) "Medical Examiners". Set fees for taking the FLEX examination. Effective date was December 29, 1982.
- 8. Health 470-132.3(147A) "Medical Examiners". Set fees for certification and renewal of Advanced Emergency Medical Technicians. Effective date was December 29, 1982.
- 9. Health 470-132.12(147A) "Medical Examiners". Extends completion date for the EMT-D Study Program to December 31, 1983. Effective date was December 30, 1982.














ANORECTIC DRUG USAGE IN IOWA 1980-1981

TOTAL NUMBER OF FEDERATION LICENSING EXAMINATIONS (FLEX) PER YEAR



